The last daye of October in the year 22<sup>th</sup> year  
of our lord god a thousand fyve hundred fyfthe eight J<sup>ohn</sup> Holloway of Crowhurst  
in the countie of Surrey yeman beinge sick in bodye but wofulle of mynd and of goodly  
memorye thanketh our lord god do ordayne and make this my last will and testiment in maner  
and forme followinge ffirst I bequethe my soule to almighty god my creatour who hath  
redeem'd me and all mankynde and my bodye to be buried in the parische churchyard of  
Crowhurst aforesaid Item I give to the high altre of Crowhurst and Item I will  
that at my buriall shalbe bestowed somme as by my overseers shalbe thought most  
necessary and sufficient in that behalf Item I give to the poore people myn Item  
I give and bequethe unto Katherine my wyfe xx<sup>th</sup> of lawfull money of Englonde Item  
also I give and bequethe to Katherine my wyfe thre halfe of my farme that I nowe  
dwelle in called Starre duringe her widowhed and all my dwelling house except halfe my  
barne halfe my Stable and halfe my Stall Also I give to Katherine my wyfe the one  
halfe of my Coorne in the Barne and about and halfe my haye Item I give and bequethe  
to Katherine my wyfe one Ox and a bull my oxen two Jeyfards my horse my mare also  
my cowle and the one halfe of all my household stuff and all good poultry as is a  
bout the house Item also I will that if Katherine my wyfe shall marrye w<sup>th</sup>in the tene  
and terme of years in myn Indenture and or all the tyme w<sup>th</sup>in the tyme of my said  
leas Item I will that if J<sup>ohn</sup> Holloway my brother shall come to w<sup>th</sup>in the tyme  
leas and terme of years then to come w<sup>th</sup>in condition that he shall here and bring  
me my said Indenture at his owne costes and charges w<sup>th</sup>inll the tyme shall come

 bout the house Item also I will that if Katherine my wife shall marry with the

 lease Item I will that if Thomas followway my brother shall have the sole farm  
 lease and term of years then to come upon condition that he shall here and bring  
 up my said estate at his proper costs and charges until he shall come  
 unto the full age of seven years Item I give and bequeath unto Thomas followway  
 my brother the one half of my farm not bequeathed to half of my barn half my  
 stable half my stall and all my horse and lands thereto belonging called Stump  
 fentment during the term of all the years Item also I give and bequeath to Thomas  
 followway my brother tenne pounds of lawful money of England to be paid  
 unto him within one month after my decease Item I give and bequeath unto the  
 said Thomas my brother in my own my life in his hands my bay mare or my gelding with  
 Item also I give and bequeath unto the said Thomas my brother a fettered bay gelding  
 bred in Wales with his appurtenances thereto belonging Item I will all the reparations of  
 all my houses that shall be needfull shall be done at the charges of Katherine my wife  
 and Thomas my brother except of them their own several portions and parts of all  
 manner houses barns stables stalle as shall be in their several occupation during the  
 term of all the years Item also I give to the said Thomas followway my brother the  
 one half of all my Corn and hay with the barn and what Item I give and bequeath  
 to the said Thomas followway my daughter with of lawful money of England to be paid unto  
 her when she shall come to the age of seven years or till at the day of her marriage and

 lease of the cowland I have and bequeath to the children of my sister Jane till  
 my of them that is to saye Robert till Thomas till a line till and James till the  
 eldest of them for the Shilling if any of them die before they come to lawful age then  
 to be the other heirs and the other so much his and theirs to be equally divided amonge  
 them that live in equall partes I have and bequeath to John Detridge and I have  
 I have and bequeath to Margaret Dpsold a bullock of one year of age I have and  
 bequeath to Elizabeth Domes my s<sup>r</sup>int a bullock of one year of age I have  
 that Katherine my wife shall have the Custody and keepinge of Alexander my sonne  
 and Andrew my daughter as long as she liveth has a widowe I have I will that  
 James Hayward shall have the stork of my children so that the said James do  
 find and put in sufficient sureties to be bound in obligatory by the laws to my  
 Cures s<sup>r</sup>er hereafter named for the redemering of all the stork of some of  
 money and other forme to be of his and theirs right after my decease in such order

 of my said & children Item I will that Thomasolloway shall paye out of my said farme  
 of the parts towards the keeping of my children a bonde of the said term shall mye  
 every year during the years Item I give and bequyte to Thomasolloway the one half

 Item the residue of all my goods and cattell stocke and some of money not bequyted  
 I give to Alexander my sonne whom I do make to be my sole executor to this my last  
 Testament to receive my goods and paye my debts and performe my legardes as in my said  
 Testament is fullye declared also if by fortune Alexander my sonne to decease before  
 he come to lawfull age then I will that all those my goods whiche shalbe descend to myne  
 by vertue of the said Testament shall devyde to the use of Garryolloway and to the  
 children of the said Garry and of the children of Thomasolloway and Joane Dill my  
 sister children equallye to be dividd amongst them in equall partes by the disposition of  
 myn onsted Item I ordyn and make to be my onsted to this my last will and  
 Testament Reynold Colindon mitgill Garward Garward of london Thomasolloway  
 Garryolloway Thomas Ederton Thomas winchester Edward winchester Garry James to see  
 this my last will and Testament to be dulye and iustlye to be kepte accordinge to the true
